## Chairman's Report

Dear Shareholders,

I am pleased to present this report of WCM Global Growth Limited (**WQG** or the **Company**) for the year ended 30 June 2024 (**FY2024**).

### Results and Performance

The Company achieved a net operating profit after tax for FY2024 of \$45,341,000 (30 June 2023: \$37,184,000). The increase in after-tax profit for the year is primarily attributed to an increase in the value of the Company's investment portfolio and the investment performance of the Company's investment advisor, WCM Investment Management, LLC (**WCM**).

For FY2024, the pre-tax net tangible asset (**NTA**) value per share of the Company increased from \$1.465 as at 30 June 2023 to \$1.744 as at 30 June 2024, representing a 19% increase. The Company's after-tax NTA per share increased by 14% from \$1.375 to \$1.565 over the same period. The higher NTA was after the payment of four quarterly dividends during the financial year totalling 6.8 cents per share (**cps**).

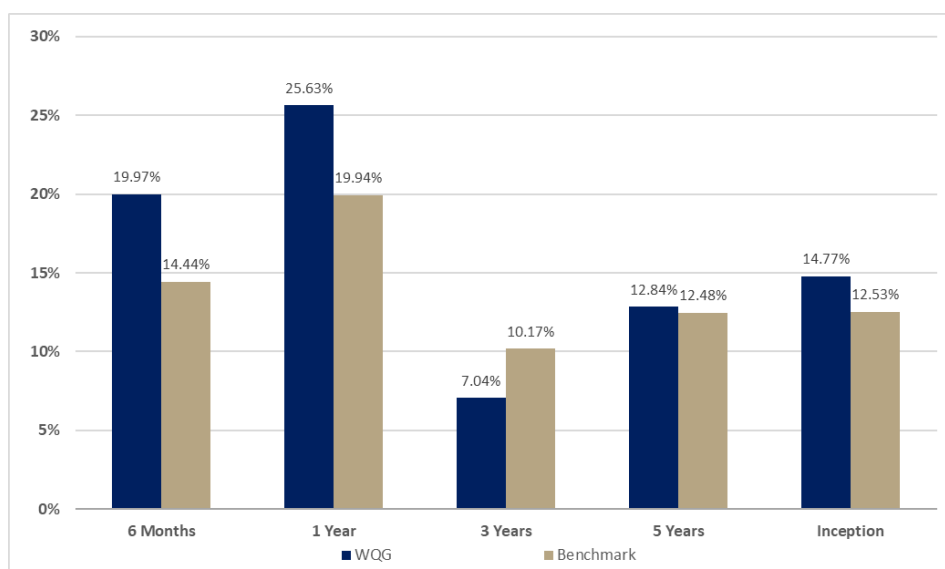
### Investment Performance

Global equity markets rallied strongly in FY2024, with several major indices reaching all-time highs. After several challenging economic hurdles in the previous financial year, including soaring inflation and rising investment rates, FY2024 saw better-than-expected outcomes for several major economies, primarily led by the outlook for interest rates. The buoyancy in markets was driven by a combination of growing optimism of a soft landing for the global economy plus the expectations of lower interest rates by the end of calendar year 2024. These improved market conditions contributed to strong investment returns for the Company in FY2024.

For FY2024, the Company's portfolio achieved a return of 25.63%, outperforming the MSCI All-Country World Index (ex-Australia) (**Benchmark**) by 5.69%, which delivered a return of 19.94%.

It is pleasing to see that the portfolio has delivered returns in excess of the Benchmark over six months, one and five years, and since inception.

Historical returns of the WQG Portfolio versus its Benchmark are shown below to 30 June 2024:

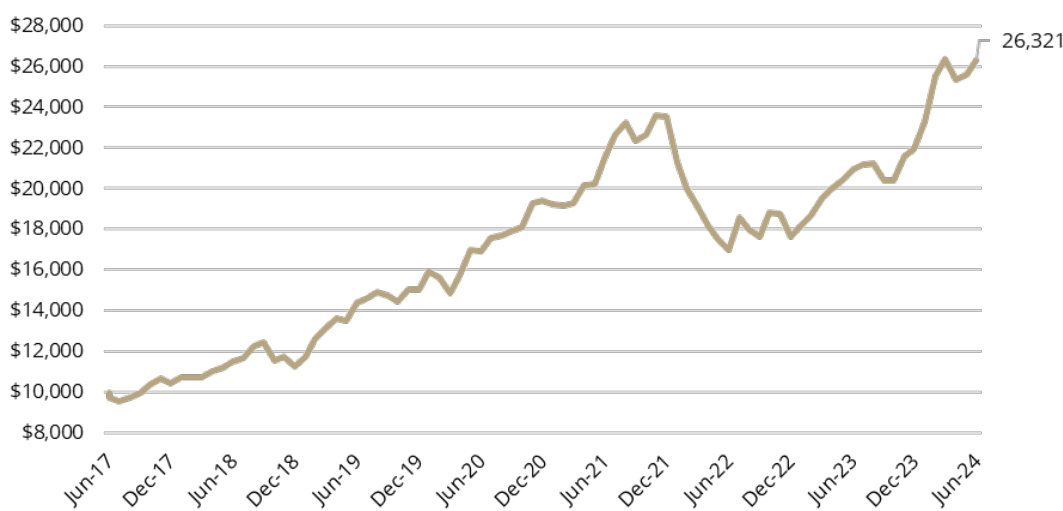

The long-term performance of the Company's investment portfolio remains strong. Since inception in June 2017, the WQG portfolio has returned 14.77% per annum after all fees compared with the Benchmark of 12.53%. This is consistent with the longer-term performance of the WCM Quality Global Growth Strategy Composite, on which WQG's portfolio is based, which has returned 14.59% per annum since inception in 2008.

As at 30 June 2024, the total portfolio value of a \$10,000 investment in the Company's initial public offer in June 2017 had grown to \$26,231 as shown in the chart below.

The continued strong investment performance since inception is a direct reflection of both the quality and expertise of WCM and its unique investment strategy: WCM believes the direction of a company's economic moat is of more importance than its absolute width or size, and corporate culture is the biggest influence on a company's ability to grow its competitive advantage or 'moat'.

### Increased fully franked final dividend and upward revision to progressive quarterly dividend intention

The Board had previously advised of its intention to pay a fully franked final dividend with respect to FY2024 of 1.76 cps in line with the Company's progressive quarterly dividend policy.

However, based on the strong financial results of the Company over the past two years and its dividend reserves and accumulated franking credits, **the Board is pleased to announce an increased final dividend for the quarter ended 30 June 2024 (Q4 FY2024) of 1.81 cps, fully franked at a 30% tax rate.** The final dividend will be paid on 30 September 2024, with a record date of 13 September 2024.

**The Company's strong financial position has also enabled the Board to revise upwards its previously announced future dividend intentions.**

Following payment of the increased FY2024 final dividend of 1.81 cps on 30 September 2024, the Board's present intention is to pay the following quarterly dividends, fully franked at a 30% tax rate<sup>1</sup>:

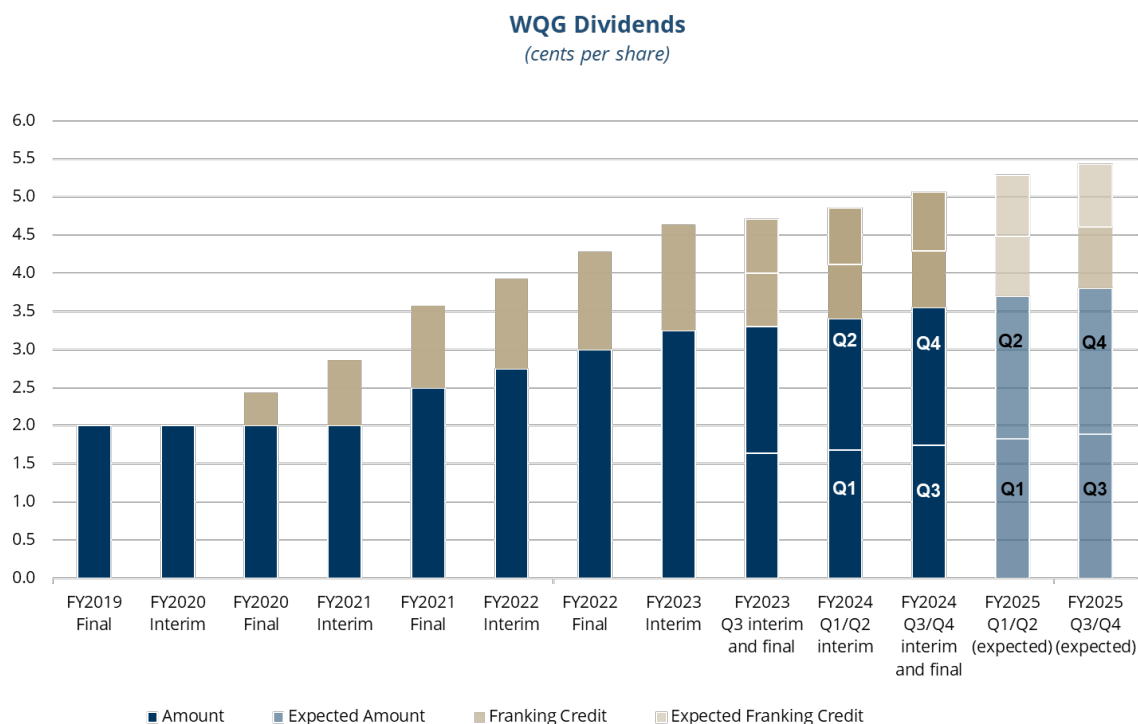
- 1.83 cps for the quarter ending 30 September 2024, to be paid in December 2024;
- 1.87 cps for the quarter ending 31 December 2024, to be paid in March 2025;
- 1.89 cps for the quarter ending 31 March 2025, to be paid in June 2025; and
- 1.91 cps for the quarter ending 30 June 2025, to be paid in September 2025.

The Company provides investors with a unique opportunity to access a fully franked income stream from a portfolio of quality global companies.

The chart below shows the increasing dividend payments and forecast dividends in line with the Company's progressive dividend policy.



### Attractive 3% DRP Issue Price Discount

The Company's Dividend Reinvestment Plan (**DRP**) will be in operation for the fully franked FY2024 final dividend of 1.81 cps. Shares issued under the DRP for the final dividend will be issued at a 3% discount to the volume weighted average price in accordance with the DRP Rules.

Participation in the DRP provides shareholders with the opportunity to increase their investment in the Company on attractive terms. All of the Directors intend to participate in the DRP for the interim dividend with respect to their own shareholdings and the Board encourages you to consider this opportunity carefully<sup>2</sup>.

### WQG On-market Buy-back

The Company continued to operate actively its on-market share buy-back during FY2024, purchasing a total of 12.3 million shares with a total value of approximately \$16.3 million. The buy-back remains in place until 26 June 2025 and continues to be an important capital management initiative which enhances shareholder value by improving returns and increasing NTA per share.

Paul has a Bachelor of Science from the University of Sydney, 1982 and a Diploma of Financial Planning from the RMIT University, 1994.

**Martin Switzer** BEc (Non-executive Director)

Martin is Chief Executive Officer and Managing Director of Associate Global Partners Limited (**AGP**), the parent entity of the Investment Manager, and has held this position since 27 October 2017. Prior to that he was a director of AGP and held that position since 25 August 2016. He is also a Non-executive Director of AGP Investment Management Limited (since 30 December 2015). Marty has over 20 years' experience in the financial services industry.

Mark is the founder of Mertons Corporate Services, now part of Acclime Australia and is responsible for Acclime Australia's Listed Services Division.

He is also an ASX-experienced director and chair of public and private companies, with expertise in the listed investment, infrastructure, bio-technology and digital sectors. He currently serves as a director on a number of Australian company boards as well as foreign controlled entities and private companies.

During his executive career, Mark held roles in banking and finance, funds management, investment and infrastructure development businesses, including being the Company Secretary for ASX:100 companies Transurban Group and Australian Foundation Investment Company Limited. Mark holds a Bachelor of Business degree in accounting, a Graduate Diploma in Governance and is a Fellow of the Chartered Governance Institute, the Governance Institute of Australia and the Australian Institute of Company Directors.

### **Company overview and principal activities**

The principal activity of the Company during the financial year was investment into a diversified portfolio of globally listed quality high growth companies sourced from developed and emerging markets outside of Australia, with the primary objective of providing long-term capital growth.

### **Results**

The Company's net operating profit after tax for FY2024 was \$45,341,000 (30 June 2023: \$37,184,000). Basic earnings per share amounted to 25.1 cents per share for FY2024 (30 June 2023: Basic earnings of 20.0 cents per share).

### **Review of operations**

The net operating profit after tax is primarily attributed to an increase in value of the Company's investment portfolio.

The Company continued to invest funds in accordance with its stated investment strategy and in accordance with the provisions of its Constitution.

The Company's policy is to maintain an unhedged portfolio, that is, its value is exposed to foreign currency movements. A rise in the Australian dollar detracts from the portfolio's value and a fall increases the value in Australian dollar terms.

For FY2024, the pre-tax net tangible asset (NTA) value per share of the Company has increased from \$1.47 as at 30 June 2023 to \$1.74 as at 30 June 2024. The increase in NTA was after the payment of a 1.66 cents per share final dividend (100% franked) for FY2023 on 29 September 2023, a 1.68 cents per share interim dividend (100% franked) for FY2024 paid on 29 December 2023, a 1.72 cents per share interim dividend (100% franked) for FY2024 paid on 28 March 2024 and a 1.74 cents per share interim dividend (100% franked) for FY2024 paid on 28 June 2024.

### **Significant changes in the state of affairs**

There have been no significant changes in the state of affairs of the Company that occurred during the year under review other than as noted in the Chairman's Report and this report.

### **Dividends paid, recommended and declared**

The final dividend for FY2023 of 1.66 cents per share (100% franked at the corporate tax rate of 30%) was paid on 29 September 2023, with a Record Date of 15 September 2023.

An interim dividend of 1.68 cents per share (100% franked at the corporate tax rate of 30%) was paid on 29 December 2023, with a Record Date of 15 December 2023.

### ***Dividends paid, recommended and declared (continued)***

An interim dividend of 1.72 cents per share (100% franked at the corporate tax rate of 30%) was paid on 28 March 2024, with a Record Date of 15 March 2024.

An interim dividend of 1.74 cents per share (100% franked at the corporate tax rate of 30%) was paid on 28 June 2024, with a Record Date of 14 June 2024.

On 15 August 2024, the Board of WCM Global Growth Limited declared a final dividend of 1.81 cents per share (100% franked at the corporate tax rate of 30%). The dividend is to be paid on 30 September 2024.

### ***Events after the reporting date***

On 13 August 2024, the Company advised the ASX that its pre-tax and post-tax NTA per share was \$1.708 and \$1.541 respectively as at 9 August 2024.

Other than as disclosed elsewhere in this report, no other matters or circumstances have arisen since the end of the financial year that have significantly affected or may significantly affect the operations of the Company, the results of those operations, or the state of affairs of the Company in future years.

### ***Likely developments***

The Company will continue to pursue its operating strategy to create shareholder value by investing in companies listed on global stock exchanges.

### ***Environmental regulation***

The Company's operations are not subject to any significant environmental regulations under a law of the Commonwealth or of a state or territory of Australia.

### ***Indemnification and insurance of directors, officers and auditors***

During the financial year, the Company has paid insurance premiums insuring all the Directors and the officers which indemnifies them against any claim made against them subject to the conditions contained within the insurance policy. Further disclosure required under section 300(9) of the *Corporations Act 2001* is prohibited under the policy terms. To the extent permitted by law and professional regulations, the Company has agreed to indemnify its auditor, Ernst & Young (EY), as part of the terms of its engagement against claims by third parties arising from the audit (for an unspecified amount). No payment has been made by the Company to EY in this respect during or since the financial year ended 30 June 2024.

### ***Proceedings on behalf of the Company***

No person has applied for leave of court to bring proceedings on behalf of the Company.

### ***Auditor's independence declaration***

A copy of the auditor's independence declaration as required under section 307C of the *Corporations Act 2001* in relation to the audit for the financial year is provided with this report.

### ***Non-audit and other assurance services provided by auditor***

The Company's auditor is EY (2023: EY). Non-audit services are approved by the Audit and Risk Committee.

The amount paid to Ms Valentina Stojanovska Cal, Mr Michael Liu, Mr Stephen Merlicek and Mr Paul Rickard is fixed at a set amount each year and is not related to the performance of the Company.

**1. Statement of material accounting policies**

The following is a summary of material accounting policies adopted by the Company in the preparation and presentation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

**a) Basis of preparation of the financial report**

This financial report is a general purpose financial report that has been prepared in accordance with Australian Accounting Standards, Interpretations and other authoritative pronouncements of the Australian Accounting Standards Board and the *Corporations Act 2001*.

The financial report covers the activities of WCM Global Growth Limited. The Company is limited by shares, incorporated and domiciled in Australia. The Company is a for-profit entity for the purpose of preparing the financial statements.

The financial report was authorised for issue by the Directors on 15 August 2024.

**(i) Compliance with IFRS**

The financial statements of WCM Global Growth Limited also comply with International Financial Reporting Standards (IFRS) as issued by the International Accounting Standards Board (IASB).

**(ii) Historical cost convention**

The financial report has been prepared under the historical cost convention, as modified by revaluations to fair value for certain classes of assets as described in the accounting policies.

The Statement of Financial Position has been presented in order of liquidity. The financial report is presented in Australian Dollars which is the functional currency of the Company.

**(iii) Critical accounting estimates**

The preparation of the financial report requires the use of certain estimates and judgements in applying the entity's accounting policies. Those estimates and judgements significant to the financial report are disclosed in Note 2.

**b) Accounting for profits and losses**

At the conclusion of each calendar month, the Company records profits earned to Retained Earnings with the intention of transferring undistributed Retained Earnings to a Dividend Reserve subject to Board approval. Losses incurred at the end of each calendar month must be recouped before a transfer to the Dividend Reserve can occur. Losses incurred at the end of each financial year are transferred to Accumulated Losses. The above process enables the Directors to declare or determine to pay dividends from the Dividend Reserve to shareholders at a future date.

**c) Going concern basis**

This financial report has been prepared on a going concern basis.

**d) Revenue**

Dividend income is recognised on the ex-dividend date with any related withholding tax recorded as an expense.

Interest income is recognised in the Statement of Profit or Loss and Other Comprehensive Income using the effective interest method for all financial instruments that are not held at fair value through profit or loss.

Net gains/(losses) on financial assets and financial liabilities held at fair value through profit or loss arising on a change in fair value are calculated as the difference between the fair value at the end of the reporting period and the fair value at the previous valuation point. Net gains/(losses) do not include interest or dividend income.

All revenue is stated net of the amount of goods and services tax (GST).

**e) Expenses**

All expenses, including the Investment Manager's fees, are recognised in the Statement of Profit or Loss and Other Comprehensive Income on an accruals basis.



**Notes to the financial statements (continued)****1. Statement of material accounting policies (continued)****f) Trade and other receivables**

Trade and other receivables may include amounts for dividends, interest and amounts due from brokers. Dividends are accrued when the right to receive payment is established in accordance with the policy set out in Note 1(d) above. Interest is accrued at the reporting date from the time of last payment in accordance with the policy set out in Note 1(d) above. Trade and other receivables also include such items as Reduced Input Tax Credits (RITC).

**g) Trade and other payables**

Trade and other payables are recognised when the Company becomes obliged to make future payments resulting from the purchase of goods and services. Payables include liabilities, amounts due to brokers and accrued expenses owed by the Company which are unpaid as at the end of the reporting period.

**h) Foreign currency translation**

Transactions in foreign currencies are brought to account at the prevailing exchange rates at the date of the transaction. Foreign currency monetary items are translated at the exchange rate existing on reporting date. Non-monetary assets and liabilities carried at fair value that are denominated in foreign currencies are translated at the rates prevailing at the date when the fair value was determined. The differences arising from these foreign currency translations are recognised in profit/(loss) on the Statement of Profit or Loss and Other Comprehensive Income in the period in which they arise.

**i) Cash and cash equivalents**

Cash and cash equivalents include cash on hand and at banks, short-term deposits with an original maturity of three months or less held at call with financial institutions and bank overdrafts.

**j) Income tax**

Current income tax expense is the tax payable on the current period's taxable income based on the applicable income tax rate adjusted by changes in deferred tax assets and liabilities.

*Deferred tax balances*

Deferred tax assets are recognised for deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred tax assets and liabilities are recognised for temporary differences at the applicable tax rates when the assets are expected to be recovered or liabilities are settled. No deferred tax asset or liability is recognised in relation to temporary differences if they arose in a transaction, other than a business combination, that at the time of the transaction did not affect either accounting profit or taxable profit or loss.

Current and deferred tax balances attributable to amounts recognised directly in equity are also recognised directly in equity.

**k) New standards adopted as at 1 July 2023**

There are no standards, interpretations or amendments to existing standards that are effective for the first time for the financial year beginning 1 July 2023 that have a material impact on the amounts recognised in the prior periods or will affect the current or future periods.

**Notes to the financial statements (continued)****1. Statement of material accounting policies (continued)****l) Financial instruments****(i) Classification and measurement****Financial assets**

The Company classifies its investments based on its business model for managing those financial assets and the contractual cash flow characteristics of the financial assets.

For equity securities, the contractual cash flows of these instruments do not represent solely payments of principal and interest. Consequently, these investments are measured at fair value through profit or loss. The Company's portfolio of financial assets is managed and performance is evaluated on a fair value basis in accordance with the Company's documented investment strategy. The Company's policy is to evaluate the information about these financial assets on a fair value basis together with other related financial information.

A financial asset is measured at amortised cost only if both of the following conditions are met:

- the asset is held with a business model whose objective is to hold assets in order to collect contractual cash flows; and
- the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets at amortised cost are subsequently measured using the effective interest rate (EIR) method and are subject to impairment.

**(ii) Recognition/derecognition**

The Company recognises financial assets and financial liabilities on the date that it becomes party to the contractual agreement (trade date) and recognise changes in fair value of the financial assets or financial liabilities from this date.

Investments are derecognised when the right to receive cash flows from the investments have expired or the Company has transferred substantially all risks and rewards of ownership.

**(iii) Impairment**

Impairment of financial assets is recognised based on the lifetime expected credit loss which is determined when the credit risk on a financial asset has increased significantly since initial recognition. In order to determine whether there has been a significant increase in credit risk since initial recognition, the entity compares the risk of default as at the reporting date with the risk of default as at initial recognition using reasonable and supportable data, unless the financial asset is determined to have low credit risk at the reporting date.

For trade and other receivables, the simplified approach is used, which requires recognition of a loss allowance based on the lifetime expected credit losses. As a practical expedient, the Company uses a provision matrix based on historical information and adjusted for forward-looking estimates in order to determine the lifetime expected credit losses. See Note 3(c) for further details

Any change in expected credit losses between the previous reporting period and the current reporting period is recognised as an impairment gain or loss in profit or loss. There was no impairment during the year and as at 30 June 2024 (30 June 2023: Nil).

**m) Goods and services tax (GST)**

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the Statement of Financial Position are shown inclusive of GST.

Cash flows are presented in the Statement of Cash Flows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

**Notes to the financial statements (continued)****1. Statement of material accounting policies (continued)****n) Rounding of amounts**

In accordance with *ASIC Corporations (Rounding in Financial/Directors' Reports) Instrument 2016/191*, the amounts in the Directors' Report and in the financial statements have been rounded to the nearest thousand dollars (\$000's), or in certain cases, to the nearest dollar (where indicated).

**o) Standards issued but not effective**

Certain new accounting standards and interpretations have been published that are not mandatory for the 30 June 2024 reporting period. The Directors have assessed that the implementation of these standards does not have a material impact on the financial report.

**2. Significant accounting estimates and judgements**

Certain accounting estimates include assumptions concerning the future, which, by definition, will seldom represent actual results. Estimates and assumptions based on future events have a significant inherent risk, and where future events are not as anticipated there could be a material impact on the carrying amounts of the assets and liabilities discussed below:

**a) Income tax**

Deferred tax assets and liabilities are based on the assumption that no adverse change will occur in the income tax legislation and the anticipation that the Company will derive sufficient future assessable income to enable the benefit to be realised and comply with the conditions of deductibility imposed by the law.

Deferred tax assets are recognised for deductible temporary differences as management considers that it is probable that future taxable profits will be available to utilise those temporary differences.

**b) Fair value measurements**

Certain financial assets and liabilities are measured at fair value. Fair values have been determined in accordance with fair value measurement hierarchy. Refer to Note 3(e) for the details of the fair value measurement key assumptions and inputs.

**3. Financial risk management****a) Objectives, strategies, policies and processes**

The Company's activities may expose it to a variety of financial risks: market risk (including price risk, interest rate risk and currency risk), credit risk, liquidity risk and risk relating to fair value.

The Company's overall risk management programme focuses on ensuring compliance with the Company's Investment Management Agreement (**IMA**) and seeks to maximise the returns derived for the level of risk to which the Company is exposed. Financial risk management is carried out by an Investment Manager under policies approved by the Board of Directors of the Company.

The Company uses different methods to measure different types of risk to which it is exposed. These methods include sensitivity analysis in the case of interest rate and price risks, and ratings analysis for credit risk.

**b) Market risk**

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: price risk, interest rate risk and currency risk. Market risk is managed and monitored using sensitivity analysis and minimised through ensuring that all investment activities are undertaken in accordance with established mandates and investment strategies.

**Notes to the financial statements (continued)****3. Financial risk management (continued)****b) Market risk (continued)**

The sensitivity of the Company's equity and profit/(loss) before income tax to price risk is measured by the reasonably possible movements approach. This approach is determined based on management's best estimate, having regard to a number of factors, including historical levels of changes in interest rates, historical correlation of the Company's investments with the relevant benchmarks and market volatility. However, actual movements in the risk variables may be greater or less than anticipated due to a number of factors, including unusually large market shocks resulting from changes in the performance of the economies, markets and securities in which the Company invests. As a result, historic variations in the risk variables are not a definitive indicator of future variations in the risk variables.

**(i) Price risk**

Equity price risk is the risk that the fair value of equities will fluctuate because of changes in market prices, whether those changes are caused by factors specific to the individual financial instrument or its issuer, or factors affecting all similar financial instruments traded in the market.

Equity price risk exposure arises from the Company's investment portfolio. The investments are classified on the Statement of Financial Position at fair value through profit or loss. All securities investments present a risk of loss of capital.

The Investment Adviser mitigates this price risk through diversification and a careful selection of securities and other financial instruments within specified limits set by the Board.

The Company's overall market positions are monitored on a daily basis by the Company's Investment Manager and are reviewed on a monthly basis by the Board of Directors.

The Company's net assets include investments in equity securities.

At 30 June 2024, the Company's market risk is affected by changes in market prices. If the exposure of financial assets and liabilities had increased by 10% with all other variables held constant, this would have increased net assets attributable to shareholders and net profit after tax by approximately \$20,744,000 (2023: \$18,758,000). Conversely, if the exposure of financial assets and liabilities at 30 June 2024 had decreased by 10% with all other variables held constant, this would have decreased net assets attributable to shareholders and net profit after tax by approximately \$20,744,000 (2023: \$18,758,000).

**(ii) Interest rate risk**

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates.

The Company's interest bearing financial assets and financial liabilities expose it to risks associated with the effects of fluctuations in the prevailing levels of market interest rates on its financial position and cash flows. The Company has established limits on investments in interest bearing assets, which are monitored on a daily basis.

In accordance with the Company's policy, the Company monitors the Company's overall interest sensitivity on a daily basis, and the Board of Directors reviews it on a quarterly basis. Compliance with the Company's policy is reported to the Board on a monthly basis.

At 30 June 2024, cash and cash equivalents to the value of \$10,327,000 (2023: \$5,214,000) are the only financial instrument subject to interest rate risk. The Company is not subject to significant amounts of interest rate risk due to fluctuations in the prevailing levels of market interest rates.

The Company has appointed AGP International Management Pty Limited as the investment manager in respect of the Company's portfolio (**Investment Manager**), pursuant to the IMA.

The Investment Manager is a related party of the Company by reason that their respective Boards have common Directors. The Company and the Investment Manager have entered into an IMA which has been negotiated on arm's length terms.

## b) Investment management fees and other fees

The Investment Manager is entitled to a management fee of 1.25% per annum (excluding GST) of the Company's portfolio value.

The Company has agreed to pay the Investment Manager a performance fee equal to 10% (excluding GST) of the portfolio's outperformance relative to the "Total Hurdle Amount" being the initial portfolio value adjusted for the benchmark return (being the MSCI All Country World Index ex-Australia with gross dividends reinvested reported in Australian Dollars and unhedged) plus the management fee over each financial year subject to full recoupment of any prior year underperformance. The maximum performance fee payable in any financial year is capped at 0.75% of the closing market value of the portfolio in each financial year.

For the 2024 financial year, the Company paid management fees of \$3,514,000 (excluding GST) to the Investment Manager (2023: \$3,264,000) and paid performance fees of \$Nil (excluding GST) to the Investment Advisor (2023: \$Nil). As at 30 June 2024, the management fee payable is \$346,000 (2023: \$302,000) and the performance fee payable is \$Nil (2023: \$Nil).

In addition, the Company has a Shared Services Agreement with 2735 CSM Holdings Pty Limited (**CSM**) to provide the use of premises and facilities, company secretarial, administrative, financial and accounting services. The Investment Manager is entitled to a Shared Services Agreement of 0.10% (excluding GST) of the Company's portfolio value. The Company paid service fees of \$295,000 (30 June 2023: \$248,000) to CSM during the 2024 financial year.

The Investment Manager and CSM are director associated entities. All of the above related party transactions are conducted on normal commercial terms and conditions.

**c) Other transactions with the Company**

In addition to these payments and as part of its normal payment of dividends on its shares, the Company made payments to Directors who held shares in WCM Global Growth Limited. All of the Directors participated in the DRP for the years ended 30 June 2024 and 30 June 2023.


